

Information on Admission to K1 Classes in the 2021/22 School Year

Collection of application Forms (No quota)

1. Download from school website
2. Obtain from school in person

Distribution Period

Whole year

Return of Application Forms (No set quota for the kindergarten)

1. Return method: Submit the application form in person, together with the documents required including: [Two photos (one of the photo will be used on the application); A photocopy of the child's birth certificate and the immunization Record (cover and content page); Three \$2 stamped addressed envelopes and a \$4 stamped addressed envelope with the child's name and own address]
2. Application fee: HK\$40 (to be collected together with the application form). The application fee is non-returnable whether the application is successful or not.

Return Period

1. Date: Whole year
2. Time: 9:00 a.m. to 5:00 p.m. (Mondays to Fridays) and
9:00 a.m. to 12:00 p.m. (Saturdays)

Application for the 2021/22 Registration Certificate for Kindergarten Admission

1. Education Bureau (EDB) will implement the Free Quality Kindergarten Education policy starting from the 2021/22 school year to replace the existing "Pre-primary Education Voucher Scheme". Under the new Scheme, EDB will use the "Registration Certificate for Kindergarten Admission" as the document for registration in the 2020/21 school year.
2. Parents are required to submit an application for the "2021/22 Registration Certificate for Kindergarten Admission" (hereafter referred as "2021/22 RC") to EDB from September to November 2020. The "2021/22 RC" will be open for applications in September 2020 and EDB will announce and upload the details of application onto EDB's website (<http://edb.gov.hk/>) in due course.

Admission Criteria

1. Agree with our education mission and purpose of association
 2. Interview performance
 3. Applicants' age eligibility
 4. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration
 5. The applicant from families in need will be given due priority consideration.
- Remarks: As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.

Interview Arrangements

1. The kindergarten will arrange interview for all applicants.
2. Interviews will be conducted on 16/11/2020.
3. Group and individual interviews will be arranged.
4. Parents should accompany their child for the interview.

Announcement of Admission Results

We will inform parents of the K1 admission results before 21st December 2020 by post.

Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child from 7th to 9th January 2021(“Centralised Registration Dates”) by submitting the original of the “2021/22 RCö” to the kindergarten and paying the registration fee.
2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the original of the “2021/22 RCö” to the kindergarten and pay the registration fee.
3. Please be reminded that if parents cannot submit the “2021/22 RCö” during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period.
4. The registration fee for 2021/22 K1 place is HK\$1,570. If parents decided to change school after registration, please notify the kindergarten by letter. The kindergarten will return the “2021/22 RCö” but the registration fee will not be refunded. Upon obtaining the “2021/22 RCö”, the kindergarten will no longer keep the school place for the child.
